Residential Property Flipping Rules – Profit from the sale of residential property (including principal residence) held less than 365 days will be fully taxable as business income and does not qualify for the principal residence exemption nor the 50% capital gain inclusion rate (some exceptions: death, marriage breakdown, involuntary disposition, change of job, bankruptcy, etc).
